3. Minors Survey – Standard Questionnaire and Process

There was support for the approach to a standard questionnaire and process. However, discussion took place on whether or not "Student Input" is a necessary requirement for Minors. It was agreed to review the Curriculum Change Impact Assessment Chart first (including a review of which type of submissions student input is required), and then revisit the discussion about a standard questionnaire and process.

The new policy is being classified a management policy due to amendments in the PSLA and adherence to Mount Royal University's Policy on University Policies and Procedures.

A draft of proposed changes that are ready for review will be presented at the next APCC meeting for consideration to move forward to the next step in the policy revision process.
