3.1. Major Program Change – Nursing, BN (effective year 2023/24)

#### Moved and seconded:

 In response to a question, it was explained that a higher grade requirement for Nursing students in the Psychology course is not required, though it was necessary due to the nature of the course it was applied to in the Midwifery program, as discussed at the previous meeting

- Concerns regarding procedures and resources required for accommodating the CASPer test required for international applicants were addressed
- It was explained that this change will attract more diverse applicants, this test requirement is being adopted broadly, and the program is prepared to work through the concerns raised; discussions have already taken place between the program and Admissions
