## 5. APCC Membership Review

5.1. Discussion to add representation from General Education (for discussion)

With removal of the "Teaching and Learning" representative position as per the definition of "Faculty" in the GFC Bylaws, and in recognition of the importance of having a voice from General Education on APCC, a discussion took place about adding representation from General Education that is best suited to APCC's mandate, specifically as it relates to General Education curriculum. It was agreed that the best representative to sit on APCC at this time is the Academic Director, Liberal Education.

#### Moved and seconded:

**THAT** the Academic Programs and Curriculum Committee recommends to the General Faculties Council that the Academic Programs and Curriculum Committee Charter be amended to add the "Academic Director, Liberal Education" to the Membership until the end of the 2024/25 academic year.

#### Discussion:

- An amendment to the main motion was proposed to include a term expiry (until the end of 2024/25) in anticipation of having more information about a revised General Education model, as per the forthcoming Academic Plan 2023-2030, and revisit the membership composition at that time.
- It was explained that this recommendation is based on current Curriculum Committee structures and addresses a current gap in APCC's membership to have representation directly from General Education.

To amend the main motion to add "until the end of the 2024/25 academic year".
