## PRIORITIZED SUMMARY OF PROJECTED ACTIVITIES AND OUTCOMES

EC will meet monthly to address items in accordance with its Charter and the GFC Bylaws. EC will finalize GFC agendas, ensure materials are available to support deliberation, and oversee the accurate recording, communication, and implementation of GFC decisions. EC will also consider items and questions submitted to GFC, referring them to standing committees or to GFC as appropriate, and will continue to address issues arising from committee work and new business. EC will support member development by advising on orientations, ongoing governance essentials sessions, and the annual GFC elections. Individual EC members will participate in various orientation opportunities throughout the year.

In accordance with the GFC Bylaws, EC will oversee the following this academic year:

- Formal Committee Charter Review (Bylaw 11.2(e)) Standing Committees will review their charters at least once every three (3) years and when necessary recommend changes to GFC. Committees will submit their recommendations to EC for review and GFC approval at the end of this academic year.
- **GFC Assessment** (Bylaw 13) GFC will carry out an assessment of its performance and operations no later than two years following its last assessment in accordance with a process approved by GFC Executive Committee. EC will consider ways to streamline the process based on previous feedback. The formal assessment is anticipated to be conducted in May 2026.
