3. Reporting Structure of General Education and Academic Development Centre

EC received information and discussed the upcoming changes to the reporting structure of General Education and the Academic Development Centre. This information will be presented to GFC at the May 19, 2023 GFC meeting, along with a proposed GFC Bylaw Revision – Definition of "Faculty". It was

confirmed to include the Notice of Motion in the April 21, 2023 GFC meeting package under the Consent Agenda – Items for Information (*Item 8.2.1*).

- 4.1. Potential for a Structured Discussion with GFC on AIC & IAC With the Associate Vice-President, Indigenization and Decolonization position vacancy, it was supported to postpone discussion with GFC about the potential establishment of an Academic Indigenization Committee. In place of that discussion, EC agreed to add the "Strategic Plan Update" to the April 21 GFC agenda.
- 4.2.
