5. Update – Three-Credit Indigenization Component

5.1./5.2. Update from the Interim Vice-Provost, Academic and Recommendation from APCC – Program Definitions Policy (Indigenous Content)

The Interim Vice-Provost, Academic gave an update on the three-credit Indigenous component from meetings with the Associate Deans to explore a solution and address challenges with a three-credit or equivalent solution, and intends to bring an update for the March GFC meeting.

The APCC Chair added that APCC expects to put forward an amended version of the proposed changes to the Program Definitions Policy for discussion at the March GFC meeting to align with the pathway that the Vice-Provost, Academic is exploring.

6. GFC Assessment Survey & Structured Discussion Results

A preliminary discussion took place about the structured discussion results related to the GFC assessment survey. The formal discussion will take place at the next EC meeting, including determining the next steps required and what to bring back to GFC.

7. GFC Committee Structure Review

With additional information provided to assist with EC's review of the GFC Committee structure, it was considered to bring a structured discussion forward to GFC in March 2023 on the two committees that have not been formed (Academic Indigenization and International Activities). The review of the established committees was also considered.

A process for a formal GFC Bylaw review will be explored in the 2023-24 academic year.

• Rather than striking a new group for the ChatGPT issue, Tim Rahilly, with EC's support, will refer the matter to TLC as there is considerable overlap in the membership that was contemplated for a group to address this with the membership of TLC and the issue aligns with TLC's mandate.
