2.1. Minutes from May 7, 2025

2.2. Business Arising from the Minutes

3. Approval of APCC Charter Revision Recommendation (Membership)

Moved and seconded:

THAT GFC Executive Committee recommends to the General Faculties Council that the Academic Programs and Curriculum Committee Charter be amended to extend the term for the Academic Director, Liberal Education until the end of the 2025/26 academic year.

Discussion:

- The Committee expressed support for the Academic Director, Liberal Education to continue to be a member of APCC, and the Committee also noted that specifying term limits in Charters is not an effective governance mechanism. Charters are formally reviewed by Committees automatically every three years.
- The recommendation will be returned to APCC with the recommendation that they remove the term limit footnote for the Academic Director, Liberal Education.
- The Academic Director, Liberal Education can continue to attend APCC meetings as a guest and participate in discussions of the Committee until the membership revision is finalized.

4. Approval of GFC Agenda

4.1. GFC Open Session Agenda – September 19, 2025

Moved and seconded:

THAT the Agenda for the September 19, 2025 GFC Open Session meeting be approved.

Discussion:

- An overview of the agenda items was given.
- In response to a question, it was explained that for the GFC Governance Essentials panel, the panel was composed of administrators unlike past panels that had faculty and/or students. That's because this session is focused specifically on the operational and administrative supports that make GFC's academic governance work possible. 4.2. Speaker for Land Acknowledgement

A volunteer sign-up form, developed following the May 7, 2025 EC meeting, will be circulated to GFC members via the GFC meeting package distribution emails. Suggestions for a speaker for the September GFC meeting were provided, and C. London agreed to confirm one of the suggested individuals.

C. London reported back to EC, as a follow-up from the previous meeting discussion, that John Fischer had met with Indigenous faculty, who expressed affirming feedback for Land Acknowledgements at GFC.

5. Draft EC Annual Plan

The draft EC 2025-26 Annual Plan was reviewed.

6. GFC Governance Essentials Planning

EC reviewed and finalized the draft plan for the September 2025 GFC Governance Essentials session.

EC discussed potential topics for upcoming GFC development sessions (October and November), with emphasis on aligning to governance priorities and member development. Suggested themes included:

- Exploring the impact and purpose of GFC through examples (e.g., program reviews, faculty/department contributions)
- Highlighting meaningful work of GFC and benefits of membership (including student perspectives)
- Overview of GFC Committees and their roles

The University Secretariat will prepare a draft plan for the next two sessions for EC's review at the next meeting.

7. GFC Orientation Schedule Details

The University Secretariat presented the orientation schedule, including a new session for Committee Chairs and Vice-Chairs. Following the November sessions, feedback will be collected from members to guide future orientation planning. Feedback on the GFC Governance Essentials will continue to be collected following each session and shared with EC.
