Mission: The purpose of the University Leadership Group (ULG) is to provide a forum for

the administrative officers of the University to share information across the

divisions, to promote discussion, and to receive feedback.

**Background:** The President's Advisory Group (PAG) was established to provide a forum for the

President to share information across the divisions, to receive advice and feedback, and to build a sense of team at the senior administrative level. As at November 2005, PAG had a membership of 32. In October 2004, this group was replaced by a smaller group, the College Management Group (now the University Management Group [UMG]), which has been charged with the responsibility to oversee the operations of the University and provide feedback to the President. The UMG serves as an advisory and recommendation body to the President and

other senior administrators.

**Authority:** The committee does not have management, operational, or decision making

responsibilities. The committee serves as a sounding board and discussion panel

to share and investigate new ideas and initiatives.

**Membership:** The University Leadership Group is chaired by the President. All of the President's

direct reports, classified as management employees, and all other management level employees, including Deans and Directors reporting to a Division Head, and Association President serve as members. The membership of CLG will be

approximately 103.
