SUMMARY OF ACTIVITIES AND OUTCOMES

The RSC had a tremendous year with highly productive Working Groups, policy advancement and valuable meeting discussions.

Topics covered at monthly meetings included:

- Indigenous Research (dr. linda manyguns guest)
- EDI for Researchers (Dr. Moussa Magassa guest)
- Undergraduate Research Experience (Sarah Imran guest)
- DORA
- Chat GPT

Policy review, recommendation and outcomes:

- The Responsible Conduct of Research (RCR and previously Integrity in Research) policy and associated procedures (RCR Procedure; Procedure for Conflict of Interest in Research; Collection, Storage and Authenticity of Research Data) were amended based on the RSC Policy Working Group (2022/23) suggestions. RSC recommended the materials for approval of GFC. GFC approval was received at the February 17, 2023 meeting. Board rescindment of the Conflict of Interest in Research Policy occurred at the March 16, 2023 board meeting.
- Institutes Policy, Institutes Procedure and Affiliated Institutes Procedure as well as the Standard
 Operating Procedure for Establishment and Recognition of Research Collaborations other than Institutes
 were reviewed by the RSC and recommended for approval by the ELT. ELT approval was received at the
 Tuesday, April 11, 2023 Dean's Council meeting.
- The RSC provided feedback on the Draft Ethics of Research Involving Human Participants Policy and Procedures. These documents will move to 30 day consultation in September followed by RSC recommendation for approval by GFC and ultimately GFC approval.

Working Groups:

- The Research Data Management (RDM) Working Group met the Tri-Council deadline for posting a RDM Strategy to the institution's website by March 1, 2023. The Group also created an oversight document to support implementation of the Strategy. Work will continue next year.
- The International Research Working Group finalized a document on conducting international research that was reviewed by the RSC and forwarded to Faculty Associate Dean's of Research (ADRs) to be shared with faculty members.
- The Undergraduate Research Working Group has identified two critical actions moving forward: maintain ongoing conversations with Career Services to make sure that undergraduate research is accurately

- captured in the E-career portfolio (ECP); develop an action plan for examining how undergraduate research is taught at MRU.
- Research and Scholarship Days were a tremendous success! From March 27 to April 6, 13 events were
 held across campus with 234 student and faculty submissions and around 850 attendees. <u>Student poster
 session winners</u> and <u>Research Recognition Award recipients</u> have been announced. Web stories on
 faculty and student research were also disseminated on the Calgary Herald site and LinkedIn. The
 Research Recognition Awards working group has now moved to the Associated/Vice Deans Research
 group.

A sincere thank you to all RSC members for their engagement in meeting discussions and for their leadership and dedication to Working Group activities.

MATTERS FOR FUTURE CONSIDERATION

The priority area for Fall 2023 will be the Mount Royal University Research and Scholarship Plan (RSP). Building on the University Strategic Plan and the Academic Plan, the RSP will outline priorities to 2028. The RSC will play an important role in informing the plan. The following Working Groups will continue or be created to provide input to the RSP:

- Research Data Management and Data Security
- International Research processes for international visitors, student RAs, hires.
- Undergraduate Research
- Indigenous Research
- Community Engaged Research
- EDI and Research

The Research and Scholarship Days Working Group will build on this year's success and the feedback provided to develop a successful event in the Spring of 2024. A key recommendation is to begin work earlier - ie in October.
