#### **3.** Indigenous Research (for discussion)

dr. linda manyguns, AVP, Indigenization and Decolonization provided an overview of Indigenous research at MRU and responded to questions, including:

- Indigenous community research policies
- limitations of Tri-Agency follow up
- the need for Indigenous research to begin with community benefit
- upcoming sessions on Indigenous protocols
- creation of a FOAP for Indigenous honorariums
- work on the *Institutional Tenure and Promotion Criteria* (with the Academic Standards Committee)

The Chair explained that next steps include further collaboration between the Office of Indigenization and Decolonization and the Office of Research, Scholarship and Community Engagement on this topic. M. Roberts shared an update that the Bissett School of Business received a gift to fund a chair in a new Indigenous Business and Economic Development (IBED) concentration that is unique in Canada at the undergraduate level.

It was explained that the new policy for Responsible Conduct of Research and associated procedures are currently in the 30-day consultation process. Members were encouraged to review the documents and that feedback can be provided until November 2. Final drafts will be presented to RSC on November 15 for recommendation to GFC and for approval by GFC at the November 25, 2022 meeting.

#### 6. Committee Chair Report

The Internal Research Grant Funding call closed on September 29, 2022 with eight applications, about half of what was expected. The second deadline will be January 13, 2023. The Faculty of Business and Communication Studies CRC in Global Value Chain search is underway. Faculty Research and Scholarship Dissemination Fund deadlines: Fall Application Deadline: December 2th, 2022 (noon) (application available in ROMEO week of Oct 31st) and Winter Application Deadline: April 28th 2023 (noon). The Undergraduate Research Dissemination Fund deadline was October 3, 2022; next deadline March 10, 2023.

A question was raised regarding the pre-travel authorization process. Through discussions, the Chair concluded that clarification on this matter is needed and will connect with the Risk Management office for more information, and potentially invite a representative from Risk Management to discuss with RSC further.
