## 4. Update to Awards Procedure Document due to Chancellor's Scholarship

Discussion focused on determining a change to the annual maximum awarded to a student in scholarships, bursaries and awards clauses, as reflected in the awards procedure document. The options considered were to adjust the limits to increase the overall amount or to remove the clause entirely.

#### Moved and seconded:

**THAT** Student Affairs Committee approve removing the annual maximum per student clause entirely from the Awards Procedure document to allow for increased flexibility.

# 5. Removal of Open Studies as an eligible program for entrance awards that have an academic requirement in the terms of reference

A summary of the proposed revision was provided. A question was raised about the exclusion of certificates and it was explained that, historically, certificates have only been included when specified. It was noted that the changes would apply only to the awards listed in Agenda Item 6.6, that there is minimal impact (low number of students impacted), and that excluded students would still be eligible for other awards.

Note: Entrance awards specific to Athletics are not to be included in this change. If approved, SAC will review language pertaining to certificates and diplomas in the next academic year.
