- Inquire whether faculty members outside of the Committee could fill the volunteer roles, as it was suggested by members that it is a good opportunity for faculty service, and;
- Make a request that the President's Scholarship meeting package materials be issued in advance to lessen the burden on committee members during the selection process.

9. Draft Annual Statistical Report of Student Misconduct

As per the Code of Student Community Standards Policy s10.1, the draft Annual Statistical Report of Student Misconduct was presented for information.

Discussion:

- The new policy came into effect as of August 1, 2023 with new processes and procedures, including the requirement for this report.
- The number of misconduct incidents was considered and a request made for comparators. It was explained that there is data from past years but that the previous process included panels, which is a different method of adjudication. In addition, the informal resolution process in the past was not always formally tracked, which makes year-over-year comparisons difficult.
- Some of the language used in the "detailed violations" chart will be reviewed ("improper" citations specifically) and hyperlinks to the policy will be included.
- Requests were made to include data on violations by course level and on the courses in which the violations occurred.
- SAC was informed that "Academic Misconduct Resources" can be located on the myMRUFaculty page.
- Discussion centered around AI and it was reported that the Provost and Vice-President, Students are co-sponsoring a working group to develop resources and approaches pertaining to AI.
