## 3. Response from the GFC Executive Committee re: Syllabus Guidelines Recommendations

## Discussion of Feedback from Syllabus Guidelines and AI

The Chair shared inquiries and feedback received related to the "Syllabus Guidelines and AI" agreed to at the previous TLC meeting, and in her capacity as the ADC Director about AI-related concerns with the optional text-matching software available for faculty, Turnitin. Feedback has been related to providing more specific guidance about using or not using AI in a teaching and learning context, academic integrity, and in an AI-detection and text matching software approach. The Chair gave a summary of Turnitin's new feature for AI detection, how ADC is working to address it, and considerations for whether the feature will be kept on (including how it relates to the MRU text-matching policy). Communication on that feature specifically will be shared with all faculty soon from the ADC.

An open discussion took place about understanding what TLC's governance role is for considering the feedback and issues being raised, and AI in a teaching and learning context. There was consensus that it is not yet clear what TLC's governance role is and how they could contribute meaningfully, given that it is being addressed by other areas at the university. The Chair will report back to GFC. Further discussions will likely be necessary once more is understood about the topic and the questions around governance that may need to be addressed.

## Response from EC on the Syllabus Guidelines Recommendations

An update was shared with TLC from the EC April 12, 2023 meeting. Extract from the EC minutes: "The Teaching and Learning Committee had asked EC for advice on next steps regarding the "Syllabus Guidelines Recommendation – Possible Paths Forward". The document will be forwarded to the Provost's Council to continue to address the recommendations and conclude that item."
