The MRU Access and Inclusion Services Religious Observance COVID-19 Vaccine Accommodation Request form is the preferred type of documentation that will be accepted for consideration of a COVID-19 Vaccine accommodation.

1. Submit a "public request" form on the Access and Inclusion website and upload the completed "Access and Inclusion Services Religious Observance Vaccine Accommodation Request" form
2. An Access Advisor will review the form and contact you if further information is required.
3. If your request is accepted, you will receive an email with your accommodation letter.
4. If you do not feel that your request for accommodation has been dealt with appropriately, you may take the matter forward to the Executive Director or Students (or designate) within five (5) days of receipt of the decision.
