Inspection	<p>Occupational Health and Safety (OHS) officer conducted an inspection with Mount Royal University. The officer was accompanied by the health and safety manager on site. The inspection was conducted in response to concerns submitted to Occupational Health and Safety. The focus of the inspection was related to potential exposure to a hazardous substance. The inspection was conducted at the academic work site in Calgary, Alberta.</p> <p>It was stated that Bird-Stuart Olson Contracting Inc. is on site conducting work in the main building as part of the continuous Major Project - G-Wing Interior Renovation, identified as the prime contractor for that work site. The OHS officer met in-person with the site superintendent on site to review activities conducted and additional observations made at the work site.</p> <p>Observations/discussions:</p> <ul style="list-style-type: none">- The employer employs approximately 2500 workers with approximately 300 workers on site at the time of the inspection.- The employer acknowledged concerns occurring on February 28, 2026 where occupants of the main building	January 30, 2026

	<p>could smell an odour, that is exhaust/ gasoline/ diesel or similar. The employer indicated an investigation into the source of the odour was conducted. It was determined the source was external, and due to weather conditions (strong west wind), it is believed the air in-take distributed the odour throughout various areas of the campus building. It was indicated a gas monitor was available during the internal investigation, however, the odour would quickly dissipate, therefore, the employer was unable to assess air quality, determine analyte(s), or the source.</p> <ul style="list-style-type: none"> - The employer indicated a joint health and safety committee is established as required by Section 13(1) OHS Act. Meetings are held quarterly and meeting minutes are available electronically. - The employer provided a hazard assessment report as required by Section 7(2) OHS Code. - The officer observed the prime contractor's daily air monitoring summary report available at the work site as required by Section 21(2) OHS Code. The employer indicated, at the time of the observed odour, air monitoring remained unreactive/ unfluctuating in the work area, as noted on the air monitoring report(s). - The employer provided the emergency response plan as required by Section 115(1) OHS Code. The employer discussed the procedures in place for workers to report a concern/ hazards as well as evacuation protocol. <p>The OHS officer issued a separate Notice to Produce (NTP) to Mount Royal University for work site specific documents.
