I am a Professor of Criminology at Mount Royal University, specialising in migration and border security, with broader research interests in public safety, security standards, and crime prevention. My work is applied in nature and regularly informs public discourse, having been featured by *60 Minutes*, *The Fifth Estate*, *Le Monde*, *MSNBC*, and all major Canadian news outlets. I serve as an expert advisor to the Standards Council of Canada and the International Organization for Standardization (ISO), contributing to the development of international security and resiliency standards. I also volunteer as the founding President of the SAFE Design Council, a federally incorporated not-for-profit that developed the world's first risk-informed CPTED certification programme. Prior to entering academia, I served for over 15 years with the Canada Border Services Agency in enforcement, policy, and advisory roles. I hold a PhD from Monash University and have been qualified as an expert witness in border security and crime prevention in British Columbia, Alberta, and Ontario.
